# Program Description (executive summary from grant application):

# CONDITION OF RENEWAL- update text related to funding.

Main Street Skowhegan proposes to have five AmeriCorps members who will coordinate and execute no-cost outdoor recreation programming designed to increase physical activity and engagement with nature for local community members in Skowhegan, Maine. At the end of the first program year, the AmeriCorps program will have increased participation rates in outdoor recreation programming by 8.8 percent (725 individuals). In addition, the AmeriCorps members will leverage an additional 30 volunteers who will be engaged in and lead community outdoor recreation programming. This program will concentrate on the Healthy Futures Focus Area. The AmeriCorps investment of \$81,500 will be matched with \$34,000; \$0 in public funding and \$34,000 in private funding.

#### **Compliance:**

#### » Program operation

AmeriCorps Members play a critical role in improving the physical and mental health and wellness of residents of Skowhegan and Somerset County-- by the implementation of the Skowhegan Outdoors AmeriCorps Program, a physical activity and outdoor recreation program designed to get community members outside, active, and engaged with nature. The program has only one site, the main program site where all AmeriCorps members as well as the Program Director are stationed. Site activities this quarter included several team-building activities and adventures to form lasting bongs among the new team. From a program perspective, members meet regularly with team leaders Ben and Chelsea as well as with program director Kristina Cannon. The members coordinated and led 51 outdoor programs free for community members. To improve their youth programming, staff has been asking participants what outdoor activities they are most interested in participating in. One very popular response was interest in fishing programs. This led to the program acquiring some fishing rods at no cost from a community member, and their members getting educated about the process to get a group fishing permit for educators from Maine Department of Inland Fisheries and Wildlife.

There have been no corrective actions to date.

#### » Member management

All five members are engaged and excited to be doing this work. They've started participating in trainings and have regular team lunches and team-building outings and adventures, and the team hangs out after hours. Specific trainings this quarter include: Risk Management with OSI, REACH Training, Protective Factors Training, XC Skiing training, Activity Planning Training, Program Planning Training. Member interviews occurred in April and the member experience

#### » Program Finances and Agency Fiscal Issues

The program and the organization are both fiscally sustainable. Main Street Skowhegan is working to develop two earned income opportunities for this summer (events with sponsorship).

- » Sustainability: New and Existing Partnerships: Skowhegan Outdoors AmeriCorps Program have deepened partnerships with other organizations in the community, including Somerset Public Health (SPC). They are working on two new programs with SPH and will receive funding from them to better train their AmeriCorps members. Their members interface regularly with these groups and their community is stronger because of it.
- » Sustainability: Increased resources (human, financial, etc.) Somerset Public Health partnership meeting, Members met with Somerset Public Health to plan and discuss our new Freshman Experience program with Madison Area High School, and our Summer Rec Camp with Madison/Anson Parks and Rec.
