Nonprofits + Elections: A Perfect Match!?

"Nonprofits have the **power** to foster a more **inclusive democracy**. People engaged by nonprofits are **much more likely** to vote than comparable voters."

Why Get Involved?

- ► Nearly 9 in 10 voters (87%) support local charities educating policymakers and businesses about the needs of the communities they serve.
- Seven in 10 voters (71%) think it is a **good idea for nonprofits to offer voter support services**, like voter registration and election day transportation.
- ► Politicians simply listen more to communities who are more engaged in elections!


New! Nonprofit Power Report

New report shows the power of nonprofits to build a more inclusive democracy.

- Nonpartisan voter engagement by nonprofits significantly boosts turnout
 - 10 percentage points or more!






Nonprofit engagement boosts turnout!



Nonprofit voter engagement drives the biggest increase among lower-propensity voters. Similarly:

- 12 pp for voters of color
- 15 pp for those earning \$20-30K
- 14 pp for young voters 18-24






America's Nonprofits Get Out The Vote Report

What percentage of nonprofits CAN do voter engagement?



ADVOCACY VS. LOBBYING

"Non-Partisan" Education,
Information, Research, and Analysis
E.g., Tobacco use is the leading cause of preventable
death in the United States.

Advocacy

E.g., Local health departments are key players in preventing and reducing tobacco use through clinical and prevention services.

Lobbying

E.g., We are asking you to vote in favor of the XX bill that increases funding for tobacco cessation programs in local health departments.

2025 Ballot Questions in Maine

QUESTION 1: VOTER ID

Do you want to change Maine election laws to eliminate two days of absentee voting, prohibit requests for absentee ballots by phone or family members, end ongoing absentee voter status for seniors and people with disabilities, ban prepaid postage on absentee ballot return envelopes, limit the number of drop boxes, require voters to show certain photo ID before voting, and make other changes to our elections?

QUESTION 2: RED FLAG LAW

Do you want to allow courts to temporarily prohibit a person from having dangerous weapons if law enforcement, family, or household members show that the person poses a significant danger of causing physical injury to themselves or others?

Direct Lobbying - the voters are acting as legislators!



Easy Actions You Can Take

- ► Nonpartisan voter registration and education
 - ▶ When
 - ▶ Where
 - How
- ► Give employees paid time off to vote



Voter Education

- **▶** When
 - ► Election Date
 - Deadline to vote early or by mail
 - ► Polling hours
 - ▶ Registration deadline (you can register day-of in Maine!)



Voter Education

- **►** Where
 - ► Polling Places
 - Early voting locations
 - ► How to find out if your polling place has changed




Voter Education

- How
 - **►** Eligibility
 - ► ID requirements (remember the ballot question?)
 - ► How to vote absentee or early in-person
 - "What's your plan for voting?"
 - ► Rides to the polls
 - ► Election Day Registration
 - ► NEW in Maine: online voter registration
 - Additional resources for voting (translation services, casting conditional ballots, etc)



Get Creative with Voter Engagement









Voter Registration: Level 2!

- ► You can also organize a registration drive!
 - ▶ Remember to be nonpartisan! Check out Nonprofit Vote and League of Women Voters of Maine for additional resources and tips
 - ► Your funding sources (federal) may prevent you from doing voter registration or lobbying. #NotALawyer

Proceed (with some caution)

- ► Candidate questionnaires (avoid scorecards!)
- ► Candidate forum (treat all candidates equally if there are likely no shows... reassess)
- ► Candidate visits (treat all candidates equally no politicking or fundraising).
 - ▶ Definitely invite elected officials when they are not campaigning they have more time then anyway!



Absolutely NO Electioneering or Partisan Political Activity

- ► Public Charities **CANNOT**:
 - ► Endorse candidates
 - ► Indicate favoritism in an election or toward a political party
 - ► Indicate support or opposition to candidates
- ► This is particularly important to pay attention to during big election years, or in the months leading up to an election
- ► Remember, other types of nonprofits CAN participate in electioneering!





Threats to Nonpartisanship

- ► For 70 years, something called the "Johnson amendment" (named after LBJ) has prohibited charitable nonprofits, including houses of worship, from endorsing or opposing candidates for public office
- In July 2025, the IRS proposed settling a lawsuit between the IRS and the National Religious Broadcasters. This settlement would effectively rule the Johnson amendment unconstitutional.
- ► What does this mean for nonpartisanship?? Stay tuned...
