1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 5 MRSA §7503, sub-§13-A**, as enacted by PL 2021, c. 155, §2, is amended
3 to read:

4 **13-A. Maine Service Fellows Program.** Develop and administer the Maine Service
5 Fellows Program under section 7506; ~~and~~

6 **Sec. 2. 5 MRSA §7503, sub-§14**, as enacted by PL 1995, c. 54, §1, is amended to
7 read:

8 **14. Annual report.** Submit an annual report to the Governor, the Legislature and the
9 joint standing committee of the Legislature having jurisdiction over state and local
10 government matters by January 31st of each year; and

11 **Sec. 3. 5 MRSA §7503, sub-§15** is enacted to read:

12 **15. Disaster response.** In conjunction with the Department of Defense, Veterans and
13 Emergency Management, compile a list of volunteers who are available at the request of
14 the Governor during states of emergency to provide emergency response and support
15 services in coordination with the Maine Emergency Management Agency. The list of
16 volunteers must include individuals who completed a term of service through an approved
17 national service position under the Corporation for National and Community Service
18 authorized under 42 United States Code, Section 12651 and veterans.

19 **Sec. 4. Appropriations and allocations.** The following appropriations and
20 allocations are made.
